WELCOME, INTRODUCTION, AND CONTEXT

- 1. A meeting of the Global Agriculture and Food Security Program (GAFSP) Steering Committee (SC) and the GAFSP Private Sector Window Donor Committee (DC) was convened virtually on December 1, 2 and 8, 2021, to decide on the allocations of GAFSP funding for the Sixth Call for Proposals¹ under the Grant Based Financing Track, which comprised of new Country-led and Producer Organization (PO)-led modalities, as well as to discuss other strategic matters related to GAFSP.
- 2. The SC Chair, Dirk Schattschneider (BMZ, Germany) welcomed new SC members, including the new GAFSP Program Manager, Kathryn Hollifield. During his opening remarks, the Chair highlighted GAFSP's ongoing efforts in response to COVID-19 pandemic, underlying that GAFSP was well suited to adapt to local conditions and flexible to respond to on the ground needs when the pandemic hit.
- 3. The Chair also gave an overview of the SC meeting objectives, which include making decisions on the Sixth Call for Proposals, launching the Producer Organization-led modality for the first time, discussing how to improve and strengthen GAFSP's Call for Proposals process, and discussing how to more systematically integrate climate into GAFSP operations. The Chair shared with the SC members the overwhelming response that the Sixth Call had received, signaling that more investments are needed.
- 4. Looking ahead to early 2022, the Chair urged SC members to focus on and prepare for another SC meeting in early 2022, which will focus on two core topics: 1) discussion of ongoing resource mobilization efforts; and 2) finalization of GAFSP 2.0, including refinements of the Monitoring and Evaluation Plan, completion of the GAFSP documents and the launch of the new Business Investment Financing Track.
- 5. At the beginning of third day deliberations, on December 8, the German SC Representative, Nora Boehm, announced that Steering Committee Chair, Dirk Schattschneider (BMZ, Germany), sends his apologies for not being in position to continue his role as chair, as he had been reassigned to a different Ministry effective immediately upon assumption of office of a new government following recently concluded elections in Germany. Steering Committee Co-Chair, Iris Krebber, assumed responsibility for chairing the December 8 discussions.
- 6. A list of meeting participants is provided in Annex 1. The draft agenda, circulated in advance of the meeting, was adopted and is provided in Annex 2.

UPDATE FROM THE TRUSTEE

7. The Trustee provided an update on funding availability, confirming a net funding available in the amount of US\$152.7 million for allocation to projects for SC funding decisions under the Sixth Call for Proposals. In addition, under existing Contribution Agreements with Australia and Germany, an installment equivalent to US\$34.9 million is anticipated to be paid by June 30, 2022. A further installment equivalent to US\$106.9 million will be paid by December 2025,² under existing Contribution Agreements with Australia, Germany, and Norway.

OVERVIEW OF SIXTH CALL FOR PROPOSALS FOR GRANT FINANCING: COUNTRY AND PO-LED

¹The Sixth Call for Proposals, launched in May 2021 and closed on September 8th, 2021. The Call is address medium-to long-term needs in response to COVID-19 and is strategically timed to fund COVID-19 recovery, and support countries to strengthen the performance, resilience, and sustainability of their agriculture sector and food systems in a changing climate.

- 8. The Technical Advisory Committee (TAC) Chair introduced the Country and PO-led modalities, presented the TAC composition, approach and methodology, observations and challenges, the inclusion of "special aspects" in the Sixth Call and answered questions from the virtual audience. Overall, 40 proposals for country-led projects, and 41 proposals for PO-led projects were submitted, with a total of approximately US\$1 billion in funding requests.
- 9. The TAC-C Chair explained the composition and profile of the TAC-C and TAC-PO and presented the approach and methodology followed to assess proposals received. The presentation also described some of the challenges observed during the process such as the tight timeline to review, reduced size of the TACs compared to previous years, complex proposal templates and inclusion of a high number of "special aspects" or themes (i.e., medium to long-term COVID response, private sector engagement, resilience and build back better, gender and the empowerment of women and girls, climate resilience, nutrition outcomes), and the high number of proposals received (GAFSP received nearly double the amount of proposal submissions for each modality versus previous calls with only one modality). The TAC-C Chair indicated that conducting a concurrent call was challenging, noting that it was unrealistic for proposals to be developed jointly given that both proposals may not be funded. The TAC-C Chair expressed support for separate calls or a two-stage process with a concept note stage for country-led and producer organization-led proposals in the future and suggested that a more limited number of "special aspects" be required only for country-led proposals.

SIXTH CALL FOR PROPOSALS: RESULTS OF TAC REVIEW FOR <u>PRODUCER ORGANIZATION-LED MODALITY</u>, DISCUSSION OF PROPOSALS, AND SELECTION OF GRANT AWARDS

- 10. During the presentation, the TAC-PO Chair presented their technical review findings and recommendations for SC consideration while highlighting the trends in submissions, observations and challenges, and the "special aspects" of the Call. Some of the challenges observed during the review process focused on quality assurance and quality at submission, complex proposal design and lack of attention to PO priority needs for capacity building and institutional development, project budgets (e.g., line items lacking explanatory notes and insufficient clarity on overhead costs, , and difficulty balancing PO and Supervising Entity (SE) roles.
- 11. The TAC-PO Chair shared that during the Sixth Call, total funding requests amounted to US\$115 million for the indicative available amount of US\$25 million. The TAC endorsed 12 proposals for a total of US\$29.85 million as per table 1 below.
- 12. The SC discussed the proposals recommended for funding by the TAC-PO, focusing primarily on the expected level of capacity of POs, capacity building, due diligence, proposal quality assurance by SEs, and how the robust/strong suggestions made by the TAC-PO (as stated in their report) are followed up later in the process. The need to include climate resilience aspects in the notification letters was also discussed.
- 13. **Decisions**: In total, the SC unanimously approved the 12 PO-led proposals to be financed (listed in Table 1) with the approved grant amount totaling **US\$29.85** million.³

SIXTH CALL FOR PROPOSALS: RESULTS OF TAC REVIEW FOR $\underline{\text{COUNTRY-LED MODALITY}}$, DISCUSSION OF PROPOSALS, AND SELECTION OF GRANT AWARDS

- 14. The TAC-Country Chair presented the results of the Country-led modality and discussed the proposals, which was then followed by a discussion and selection of grant proposals by the SC. The presentation focused on overall trends in Country-led submissions, findings on "special aspects" of the Call, observations and challenges, and country ranking and funding recommendations. Overall, 40 project proposals were received, which is an unusually high number compared to the typical 19-21 proposals in previous Calls. Some of the challenges observed included quality assurance issues, and incomplete information in proposals. The TAC-C Chair shared that during the Sixth Call, the total funding requests amounted to US\$887.76 million for an available amount of US\$125 million.
- 15. The SC undertook a substantive discussion about the proposals recommended for funding by the TAC and agreed which country submissions would receive grant allocations in this 6th Call for Proposals including on the maximum amount to be awarded for each successful submission, and responsible SE(s) partners for each grant.
- 16. **Decisions:** (i) The SC unanimously approved financing for the top ranked eight proposals, consistent with the indicative allocation of \$125M (see Table 2 below).
- 17. For South Sudan, the SC agreed to conduct an additional review of the project earlier than the envisioned mid-term review, which is currently expected after two and half years, to potentially reorient activities or change implementation arrangements resulting from change in the local context. Similarly, it was also recommended that the relevant SE team continuously review project geography.
- 18. Finally, the SC agreed that notification letters should include language to support to "building back better", climate resilience, and sustainability of the projects, in addition to gender and women's empowerment components. Furthermore, the notification letters will include language stressing the importance of CSOs participation and engagement throughout the project cycle.

- 19. **Decisions:** (ii) Additionally, based on TAC-C recommendation, the SC agreed to provide additional funds to Lao PDR and Bhutan in the amounts of US\$3 million and US\$1 million, respectively, to complete the total requested amount in these two proposals, contingent on the receipt of additional funds from GAFSP contributors by June 30, 2022. This would bring the grant financing to Lao PDR to US\$20 million, and to Bhutan to US\$13 million. The overall grant financing to Country-led projects would then increase from US\$121 million to US\$125 million.
- 20. The SC also provisionally approved four additional projects (listed in the table below) for financing, conditional on additional funds becoming available from donors to GAFSP by December 31, 2022. It was noted that the SC would need to formally approve the funding for the following country project proposals, upon consultation from the Program legal department, via email.

TAC Lessons Learned from the Sixth Call for Proposals

- 21. The TAC-C and TAC-PO Chairs shared lessons learned and recommendations from their role in the 6th Call, focusing on the TAC's process and GAFSP's scale up of the PO-led modality. They noted the high demand for GAFSP support from eligible countries, noting that the demand is expected to continue. Good projects in both tracks added value and focused on climate resilience, women and girls, nutrition, and strengthening POs.
- 22. The presentation also focused on strategic issues such as quality of proposal submissions, SEs role in this process, and recommendations to SEs on how to overcome various challenges. These recommendations included introducing a 2-stage processing approach; reducing the number of proposals by limiting one PO-led proposal per country; improving Guidelines and Template; improving TAC mobilization and related internal processes; increasing quality assurance from SEs; increasing the timeframe for TAC review of submissions; avoiding concurrent calls; and reducing the number of "special aspects" or priority areas per Call.
- 23. The SC endorsed the recommendations of the TAC, noting that the TAC lessons are clear and follow-up actions have the potential to transform the way high impact food & agriculture investments are done. They asked the CU to further explore the recommendations with SEs and other constituents in coming months, with a view to taking concrete action to implement them. The SC membership recognized the need for a clear role and cutting-edge capacity and support throughout the project life cycle (from proposal preparation through project design, implementation and outcome reporting), through the SEs.

24. **Actions**: The SC requested that the CU organize a dedicated session to discuss further the TAC recommendations in 2022 Quarter 1 (if possible) and agree on next steps.

Update from the CSOs

- 25. A CSO representative made a joint presentation on behalf of three CSO members of the SC, focusing particularly on CSO activities, adaptation to COVID-19 and an update on the progress of Missing Middle Initiative (MMI) projects. CSOs conducted consultations with farmers on their needs, including access to credit, seeds, markets, and capacity building; social safety net mechanisms; trade policies; aspects of sustainability and inclusivity; as well as economic impacts on informal workers.
- 26. The presentation also focused on innovative solutions from the MMI projects, including the introduction of virtual call centers in Bangladesh to support connections between producers and consumers during the pandemic. Other areas of focus included CSO actions to support GAFSP advocacy efforts, MMI and the GAFSP 2.0, engagement with POs on the ground, and the way forward, including CSOs focus to strengthen the relevance of the PO-led track as a key pathway to fight hunger and malnutrition. The SC discussion focused on lessons learned from COVID-19 and MMI projects. The SC members discussed the mechanisms for better coordination between CSOs and SEs, and articulation of PO and SE roles.

Climate Concept Note

27. The CU presented various options and activities across the GAFSP's program and project life cycle, for the SC's consideration, to better highlight the program's current climate activities and achievements and to amplify GAFSP's ambition on climate. The SC agreed with the concept note's overall approach, recognizing the need to maintain GAFSP's focus on agriculture, food and nutrition security, in a manner that ensures that GAFSP remains country/locally led.

28. Actions:

- The SC requested that a Climate Working Group (CWG) be created to move GAFSP's climate agenda forward, including through consultations in January/February of 2022, towards the preparation of a concrete proposal for SC consideration by April 2022.
- SC members were asked to formally submit their interest in participating the working group. SC members were also asked to send their organization's climate policy document to CU.

Portfolio Update

- 29. The CU provided an overview of the key strategic challenges and opportunities facing the GAFSP public sector portfolio; a summary of key results and cross-cutting themes; and offered a list of actions to strengthen portfolio health. The GAFSP public sector portfolio has US\$1.37 billion in grants with 68 projects in 39 countries, including 5 MMI projects. By geographic distribution, 60% of funds support projects in Africa. Cumulatively, US\$980 million have been disbursed, which accounts for 72% of allocated funds. The CU announced that the GAFSP portal/executive dashboard will be launched in January 2022.
- 30. The IFC Private Sector Window Secretariat presented a few portfolio highlights, including the updates of the private sector portfolio projects amid COVID-19 pressures. Cumulative approvals to date include US\$436 million for 81 investment projects and US\$40 million for 88 advisory services (AS) projects. With the ongoing global pandemic, these projects weathered the economic challenges well, as most businesses were able to adapt within 6 to 12 months. Over the period of FY13-21, for every dollar that GAFSP has invested into projects, it has leveraged 1.9x funding on average from

International Finance Corporation (IFC) and 6.6x in total financing (project size). The Private sector projects have reached 1.6 million farmers and provided direct employment to more than 24,000 people.

31. Actions: CU to convene a meeting to discuss portfolio with SE members in early 2022.

NEXT STEPS AND CLOSURE

- 32. The SC Co-Chair proposed March 2022 for the next SC meeting, with particular focus on the finalization of climate approach, resource mobilization, GAFSP restructuring/GAFSP 2.0, the next Call for Proposals, and the process for nominating and electing a new GAFSP Chair.
- 33. The meeting concluded with thanks from the Chair to all participants, organizers, and contributors.
